**NOTICE TO ELECTORS: THIS BALLOT MAY BE INVALID UNLESS INITIALED BY 2 ELECTION INSPECTORS. IF CAST AS AN ABSENTEE BALLOT, THE BALLOT MUST BEAR THE INITIALS OF THE MUNICIPAL CLERK OR DEPUTY CLERK. IMPORTANT: USE A #2 PENCIL OR THE MARKING PEN PROVIDED. DO NOT USE RED INK!**

To vote for the candidate of your choice, complete the arrow to the **RIGHT** of the candidate's name. To vote for a person whose name does not appear on the ballot, write the person's name on the line provided and complete the arrow to the **RIGHT** of the line. **When voting for president or vice president, you may vote only for the candidates on one ticket jointly or by writing in the names of persons in both spaces. A write-in vote only for a vice presidential candidate will not be counted. You must vote for individual candidates.**
