

**TOWN OF SUMNER ORDINANCE TO APPOINT ALTERNATE MEMBERS FOR  
BOARD OF REVIEW

**SECTION I – TITLE AND PURPOSE**

This ordinance is entitled the Town of Sumner Ordinance to Appoint Alternate Members for Board of Review. The purpose of this ordinance is to provide, upon lawful removal of named members or members unable to serve for any reason , alternate persons to serve as replacements to the Board of Review for the Town of Sumner.

**SECTION II – AUTHORITY**

The Town Board of the Town of Sumner, Jefferson County, Wisconsin, has the specific authority under s. [70.47 \(1\) \(6m\)\(c\)](#), Wis. Statutes. to appoint alternate members to serve on the board of review when standing members are removed from individual cases.

**SECTION III – ADOPTION OF AN ORDINANCE**

This ordinance, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, Pursuant to Section 70.47 (6m)(c) and Sec. 70.46 (1) of the Wis. Statutes, hereby provides for the appointment of alternates to serve on the town board of review in the event a standing board member of the board of review is removed or unable to serve for any reason.

**SECTION IV-- APPOINTMENTS**

The Town Board of the Town of Sumner, Jefferson County, Wisconsin, by this ordinance, names the following electors as alternates in the order indicated to serve as alternate board of review members: The alternate, once notified, if he or she approves the appointment, and if the appointment would not violate s. [19.59](#), Wis. stats., shall then take the oath of office and act as a member of the board of review under s. [70.47 \(6m\) \(c\)](#), Wis. stats.

**SECTION V – EFFECTIVE DATE**

The appointments made in this ordinance are for the Year 2014 Board of Review proceedings and succeeding years until such appointments are rescinded by action of the town board and is effective on publication or posting.
